Creating a Donor Advised Fund (DAF) at Texas Methodist Foundation (TMF)

Step One: Contact Pamela Gray at (512) 583-1928 or via email at pgray@texasmethodistfoundation.org to initiate the creation of your DAF at Texas Methodist Foundation.

Step Two: Make an initial contribution in the form of cash, securities, or other assets after your DAF is created.

Step Three: Recommend a grant to support Jesse C. Fletcher Seminary

Recommending a Grant from Your Existing Donor-Advised Fund (DAF)

Step One: Recommend a grant from your sponsor (e.g. Fidelity, Schwab, Vanguard, et al) to Texas Methodist Foundation
EIN / Tax ID Number: 74-1363741

Step Two: Inform TMF of the amount of the incoming grant, the anticipated processing date, and confirm the appropriate account number for Jesse C. Fletcher Seminary

Making a Qualified Charitable Distribution (QCD) from your Individual Retirement Account (IRA)

*This option is only available to individuals 70 ½ years of age and older; maximum amount for 2025 is \$108,000 per IRA account holder per year.
